ACTION REQUESTED:

Approval to award Invitation for Bids Y20-1055-AV, Meter Boxes, to the low responsive and responsible bidder, Core & Main LP, in the estimated contract award amount of \$4,070,917.50 for a three-year term. Further, request authorization for the Procurement Division to renew the contract for two additional one-year terms.

## PROCUREMENT:

This contract will provide equipment that is essential for the installation of water meters in both water and reclaimed water distribution systems which are crucial to the expansion, operation and maintenance of the water distribution system.

## FUNDING:

Funding is available in account number 4420-038-1536-6350.

APPROVALS:

The Utilities Department and Business Development Division concur with this recommendation.

## **REMARKS**:

Six bids were received in response to this Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. Core & Main LP has a satisfactory record of performance, is considered responsible, and has the necessary manpower and equipment to perform this contract. Therefore recommendation for award is made to Core & Main LP.
