## I. EXPLANATION & SUMMARY:

By enacting Chapter 17, Article III, Division 4 of the Orange County Code (the "Minority/Business Enterprise Ordinance"), the Board established contracting and subcontracting participation goals for minority and women business enterprises ("M/WBE(s)") that are related to the County's procurement of construction, professional services, other services, and goods (the "M/WBE Participation Goal(s)"); and

("Contract and Subcontract Goals") and providing for codification and an

Presently, pursuant to subsection (d) of Section 17-321, Orange County Code, so long as construction firms are the lowest bidders within the thresholds presented in a "sliding scale" therein, the County is required to award construction contracts to firms that have neither: (1) met the County's M/WBE Participation Goal; nor (2) made a good faith effort in assisting the County in meeting such goal.

This provision has contributed to lower than desired achievement of the M/WBE Participation Goal related to construction contracts. As a result, staff requests the Board's

approval of the presented ordinance amendment, which deletes the above-discussed "sliding scale" provision. Once deleted, all construction contractors could be required to either: (1) meet the County's M/WBE Participation Goal; or (2) provide the County with evidence that it made a good faith effort to meet such goal, in order to be awarded a construction contract.

#### **ORDINANCE NO. 2020-**

AN **ORDINANCE** AMENDMENT PERTAINING TO **MINORITY/WOMEN** BUSINESS **ENTERPRISE** PARTICIPATION, DELETING SECTION 17-321(D) FROM CHAPTER 17, ARTICLE III, ORANGE COUNTY CODE, SECTION 17-321 ("CONTRACT DIVISION 4. AND GOALS") AND SUBCONTRACT PROVIDING FOR **CODIFICATION AND AN EFFECTIVE DATE.** 

WHEREAS, the Orange County Board of County Commissioners (the "Board") has a demonstrated compelling government interest in remedying past and current discrimination in
 the procurement of goods and services by Orange County, Florida (the "County"); and

18 WHEREAS, in Chapter 17, Article III, Division 4 of the Orange County Code (the "Minority/Business Enterprise Ordinance") the Board established contracting and 20 subcontracting participation goals for minority and women business enterprises ("M/WBE(s)") that are related to the County's procurement of construction, professional services, other services, and goods (the "M/WBE Participation Goal(s)"); and

- WHEREAS, under certain circumstances, subsection (d) of Section 17-321, Orange County Code, requires that the County award construction contracts to firms that have neither:
  (1) met the County's M/WBE Participation Goal; nor (2) made a good faith effort in assisting the County in meeting its M/WBE Participation Goals; and

WHEREAS, based on lower than desired achievement of the M/WBE Participation Goal
 related to construction contracts, the Board now finds it necessary to amend Section 17-321,
 Orange County Code, to remove that above-referenced requirement.

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF 34 ORANGE COUNTY, FLORIDA:

Section 1. Amendment; In General. Throughout this ordinance, additions are shown by underlines, deletions are shown by strikethroughs, and asterisks (\*\*\*) indicate portions of text
 which have not changed.

Section 2. Amendment to Section 17-321. Section 17-321 ("Contract and subcontract goals.") is amended as follows:

48	(d) If in the bidding for a construction contract the established level and percentage subcontract goals are not achieved by the low bidder, and it is deemed that a good faith effort for
50	compliance has not been shown by the low bidder, then the bid shall be rejected by the purchasing manager as nonresponsive but
52	only if the next lowest responsive bid does not exceed the low bid by more than:
54	(1) Eight (8) percent on contract awards up to
56	one hundred thousand dollars (\$100,000.00);
58	(2) Seven (7) percent on contract awards from one-hundred thousand dollars (\$100,000.00) to five hundred
60	thousand dollars (\$500,000.00);
62	(3) Six (6) percent on contract awards from five hundred thousand dollars and one cent (\$500,000.01) to
64	seven hundred fifty thousand dollars (\$750,000.00);
