SUBJECT: August 11, 2020 – Consent Item 5-Year Public Housing Agency (PHA) Plan and Streamlined Annual PHA Plan

The Department of Housing and Urban Development requires all Public Housing Agencies to submit a 5-Year Public Housing Agency (PHA) Plan and an Annual PHA Plan. The 5-Year PHA Plan identifies long-term strategies to meet the housing needs of the elderly, disabled, and very-low income families that participate in the Housing Choice Voucher Program, known as Section 8 Rental Assistance, for the period of October 1, 2020 through September 30, 2025. The Streamlined Annual PHA Plan identifies the housing strategies within the 5-Year PHA Plan that will be implemented during the period of October 1, 2020 to September 30, 2021.

In accordance with the requirements of the Housing Choice Voucher Program, a Resident Advisory Board composed of tenants currently participating in the Section 8 program met to review the Plan on April 15, 2020. The Advisory Board members did not have any objections or concerns regarding the 5-Year Public Housing Agency Plan or Annual Plan. In an effort to solicit input on the Plan, a notice soliciting public input was published in the Orlando Sentinel on May 28, 2020. The notice provided a 21-day public comment period. Additionally, a public hearing was conducted on June 17, 2020 to provide an opportunity for the public to comment on the Plan. There were no comments received during the public comment period.

	During the last fiscal year (2019), 111 applications were pulled from the Section 8 waitlist. To date, there are 330 families on the Section 8 Waitlist. The HOME Tenant Based Rental Assistance Program (TBRA) for elderly/disabled households has 188 households active for a 94% leased up rate. Sixty-one (61) of sixty-four (64) VASH vouchers are active for a 93% leased up rate. We also have 8 active Tenant Protection Vouchers (TPV) and 1 pending lease up. Our Family Self Sufficiency Program has 39 active participants and 8 graduates in 2019. Orange County Housing continues to administer a successful Homeless Continuum of Care program with over 80 active tenants. Ongoing training is provided for staff and landlords as needed.
