Approval to award Invitation for Bids Y20-768-RM, Orange County Bridge No. 754081 University Boulevard, Bridge No. 754103 Chickasaw Trail & Bridge No. 754124 CR527 (South Orange Avenue) South Bound Deficiency Repairs, to the low responsive and responsible bidder, Proshot Concrete, Inc. in the total contract award amount of \$341,532.50

PROCUREMENT:

Work under this contract consists of deficiency repairs including materials and sequence repair steps for the three bridges. The project is located in Districts 3, 4 and 5.

FUNDING:

Funding is available in account number 1004-072-2912-3816.

APPROVALS:

The Roads and Drainage and Business Development Divisions concur with this recommendation.

REMARKS:

Five bids were received in response to this Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. The bids of Bridge Masters Construction, LLC, E&D Contracting Services, Inc., and Southern Road & Bridge, LLC were deemed non-responsive for failure to provide the original bid bond. The bid of M&J Construction Company of Pinella was found non-responsible because their references did not meet the minimum requirements. References provided were satisfactory for this type of work and Proshot Concrete, Inc., has been determined to be responsible. Therefore, award is recommended to Proshot Concrete, Inc.

The Business Development Division evaluated one bid submitted for this project. The sole bidder was not an Orange County certified Minority/Women Business Enterprise. The scope of services for this project had Minority/Women Business Enterprise availability. At the time of bid opening, at least 32 M/WBE firms were certified to provide the scope of services at the subcontract level.

The apparent low bidder, Proshot Concrete, Inc. did not achieve good faith effort documentation and reported 0% M/WBE participation in their bid

Our evaluation of these bids was based on the participation listed on the subcontractor/supplier page. If the low bidder is not chosen, please let us know so that we may obtain Letters of Intent to confirm the participation.

Attached is a spreadsheet reconciling the bidders' compliance with the Invitation for Bid's M/WBE requirements, including the percentage breakdown for all bidders and a comparison of the relative bids versus participation percentages.
