## RECOMMENDATION:

Approval of Contracts, Request for Proposals Y20-1032-AH, Housing Opportunities for Persons with AIDS (HOPWA), in the overall total annual amount of \$5,094,928.87 by Lot to: Aspire Health Partners, Inc. for Lots 1, 2, 3, 4, 5 and 6 in the annual amount of \$1,271,951.20; Catholic Charities of Central Florida, Inc. for Lots 1 and 2 in the annual amount of \$407,132.67; Center for Multicultural Wellness and Prevention, Inc. for Lots 1, 2, 3, 4 and 5 in the annual amount of \$1,130,356; Homeless Services Network of Central Florida, Inc. for Lots 3 and 5 in the annual amount of \$541,531; Miracle of Love, Inc. for Lots 1, 3, 4, 5 and 6 in the annual amount of \$1,582,868; and X-Tending Hands, Inc. for Lot 2 in the annual amount of \$161,090.

Request authorization for the Procurement Division to execute contracts for a one-year term. Further request authorization to renew the contracts for two additional one-year terms.

The proposals were evaluated by the Procurement Committee on September 9, 2020. Commissioner Christine Moore was assigned to the Procurement Committee.

### PROCUREMENT:

These contracts will provide affordable housing options and related housing services for low income persons with human immunodeficiency virus (HIV) and their families in order to achieve and maintain housing stability, avoiding homelessness, and improving their access to, and engagement in, HIV/AIDS treatment and care.

## **FUNDING:**

Funding is available in account numbers 7734-060-7312-8610 and 5888-060-8590-8610. Funding for this project is from the City of Orlando HOPWA grant from the U.S. Department of Housing and Urban Development (HUD).

## **REMARKS:**

Funding for these services comes from the City of Orlando, who receives the HOPWA funds from HUD. The HOPWA program was authorized by the AIDS Housing Opportunity Act and amended by the Housing and Community Development Act in 1992. The program is designed to provide state and local governments with the resources and incentives to devise long-term, comprehensive strategies for meeting the housing needs of low income persons with AIDS or related disease and their families.

Orange County serves as the administrator of the formula grant-funded HOPWA program for the Orlando Eligible Metropolitan Statistical Area, including Orange, Osceola, Lake, and Seminole Counties. The Orange County Health Services Department is the department assigned to administer the grant.

Six proposals were received from agencies in response to this Request for Proposals. The proposals were evaluated by a Procurement Committee and the recommendation was to award contracts to all proposers in the following service categories:

Lot 1: Supportive Services/Case Management

Lot 2: Facility-Based Housing Assistance

Lot 3: Tenant-Based Rental Assistance

Lot 4: Short-Term Rent, Mortgage, Utilities

Lot 5: Permanent Housing Placement

Lot 6: Short-Term Supported Housing
