On **October 13, 2020**, the Board of County Commissioners adopted the 2020-1 Regular Cycle State-Expedited Review Amendment to the Orange County Comprehensive Plan.

The Florida Department of Economic Opportunity (DEO) has notified the Planning Division that they reviewed the amendment in accordance with the State-Expedited Review process and did not identify any provision that necessitated a challenge to the Ordinance adopting the amendment.

Therefore, in accordance with the 31-day appeal period, the effective date for the 2020-1 Regular Cycle State-Expedited Review Amendment adopted by **Ordinance 2020-27** is **December 3, 2020**.

Dear Mayor Demings:

The Department of Economic Opportunity ("Department") has completed its review of the comprehensive plan amendment adopted by Orange County (Amendment No. 20-06ESR (Proposed as 20-03ESR) by Ordinance No. 2020-27 on October 13, 2020. We have reviewed the amendment in accordance with the expedited state review process set forth in Section 163.3184(2) and (3), Florida Statutes, and identified no provision that necessitates a challenge of the Ordinance adopting the amendment.

If the plan amendment is not challenged by an affected person, the amendment will become effective 31 days after the Department notified the local government that the plan amendment package was complete. If the plan amendment is challenged by an affected person, the amendment will not become effective until the Department or the Administration Commission enters a final order determining the amendment to be "In Compliance."
