On September 22, 2020, the Board approved an estimated budget for the U.S. Department of Agriculture (USDA) Child Care Food Program grant in the amount of \$1,570,564. The USDA, through the Florida Department of Health, awarded this grant to Orange County for the period of October 1, 2020 through September 30, 2021 in the amount of \$1,822,514. This represents an increase of \$251,950.

The Child Care Food Program is a federally funded program that reimburses child care providers for serving meals to eligible children. Children enrolled in Head Start are automatically eligible to receive free meal benefits.
