March 2021 Non-Profit Safety Grants

The Neighborhood Services Division administers the Non-Profit Safety Grant which provides funds up to \$10,000 to non-profit organizations to implement crime prevention and public safety related projects and initiatives in Orange County. This grant is supported by the local Crime Prevention Fund which also funds the Safe Neighborhoods Program, the Pine Hills Neighborhood Improvement District, and Orange Blossom Trail Safe Neighborhood.

After a detailed review of each grant application, the Neighborhood Services Division forwarded eight applications to the Neighborhood Grants Advisory Board (NGAB) for review on January 21, 2021. Upon approval, the non-profit organization must implement the project/initiative and then be reimbursed by the County.

The NGAB is recommending approval of the March 2021 Non-Profit Safety Grants to Aspire Health Partners, Inc. (\$9,500), Center for Independent Living in Central Florida, Inc. (\$10,000), Children's Safety Village, Inc. (\$10,000), Covenant House Florida, Inc. (\$10,000), Harbor House of Central Florida, Inc. (\$10,000), Lighthouse of Central Florida, Inc. (\$10,000), Mental Health Association of Central Florida, Inc. (\$7,500), and Victim Service Center of Central Florida, Inc. (\$5,000). The Non-Profit Safety Grants for March 2021 total \$72,000 (see attachment A). The grant requests are displayed in greater detail in attachments B through I.
