COVID-19 Statistics

COVID-19 Cases in Orange County

- Over 116,000 cumulative cases
- 1,126 deaths
- 14 days' average positivity rate is approximately 5.5%
- Vaccine is clearly having a positive impact

COVID-19 Testing

- Convention Center, Barnett Park
- Averaging 2,000 tests per day
- Barnett Park site will remain open through March 31, 2021



COVID-19 Statistics

COVID-19 Vaccinations

- **Over 285,000 doses administered in Orange County**
- **Over 94,000 Orange County seniors (65+) have been vaccinated (58% of senior population)**
- **15% of Orange County residents (18+) have been vaccinated**



COVID-19 Statistics

COVID-19 Vaccination Initiatives

- **Orange County eligibility**
 - **65+ years old**
 - **Educators, Law Enforcement and Firefighters of all ages**
 - **Child care providers**
 - **High risk patients with physician authorization**
- **Orange County Convention Center**
 - **3,000 doses per day, 6 days a week**
- **OCFRD initiatives**
 - **Extensive support to Convention Center site**
 - **Senior living communities – approximately 6000 vaccinations**
 - **Homebound vaccine initiative began March 1, 2021**



COVID-19 Statistics

COVID-19 Vaccination Initiatives

▪ FEMA Sites

- Valencia College – West Campus
- Averaging over 2,000 vaccinations per day

▪ Community Spoke sites

- Averaging over 500 vaccinations per day
- Englewood Community Center – 2,150 vaccinations in 4 days
- Current site is located at Kelly Park
- Site will transition to new areas in the county, at the direction of FEMA

Emergency Rental Assistance Program

- **Total Applicants in Portal – 2,467**
- **Total Applicants Submitted – 1,041**
- **Total applications under review – 613**
- **Total Approved – 10**
- **Total Denied - *40**

***All the current denials are for residents who do not qualify because they live in the City of Orlando or outside of Orange County.**



Emergency Rental Assistance Program

- **The rollout was very strong and a large number of tenants applied.**
- **Applications for both tenant and landlord are streamlined and easier to complete.**
- **Landlords can apply for multiple tenants with one application.**
