



## INTERNATIONAL DRIVE CRA

- 7,315 acres
- Created in 1998 (sunsets in 2028)
- Focused on Transportation-related Blight
- Redevelopment Plan Adopted in 1998
- Amended in 2006, 2009, and 2019
- Includes proposed redevelopment activities



## **FUNDING**

- Tax Increment Financing (TIF)
- Based on taxable value of properties within CRA
- Capture growth of ad valorem tax revenues within CRA
  - Base Year (1998) taxes continue to support General Fund
  - Growth of taxes in subsequent years (TIF) funds redevelopment activities
- Dedicate those funds to specific improvements within CRA
- Does not impact ad valorem taxes supporting schools
- FY 20 Tax Increment \$22M






## **LAND USE ANALYSIS**

Land use and transportation system must be coordinated to assure connectivity and mobility for residents, employees, and visitor populations








- Sustainable Infrastructure

## **TIF PROJECTIONS THROUGH 2040**

- Extend sunset date by 12 years to 2040
- Low Scenario: average annual contribution to Trust Fund = \$26,954,500
- Medium Scenario: average annual contribution to Trust Fund = \$29,548,800
- High Scenario: average annual contribution to Trust Fund = \$32,720,700



## **TIF PROJECTIONS**

- Extension to 2040
- TIF Revenue projections are sufficient in all scenarios
- Proposed Cap on CRA Revenues \$22M (status quo)
  - 75% of revenues above Cap rebated back to General Fund
  - \$81M (estimated) returned to supplement Countywide needs
- Allows sufficient revenues to address needs within Key
   Plan Elements of the redevelopment program

## **INVESTMENT EXAMPLES:**


- Leverage with Federal, State, Private funds to produce mixed-income affordable/attainable residential communities
- Preserve homeownership in Tangelo Park through Homeowner's Rehabilitation Program for existing low income households and Homeownership Program for new homeowners
- Engage employers in housing opportunities for their employees through partnerships with nonprofit housing agencies to provide homebuying workshops and credit counseling workshops





Traffic congestion is a problem in this area.




#### **EMPLOYEE SURVEY**

Building an enhanced transit system is a critical need in this area (i.e. buses, trains and other modes of transportation).






#### **EMPLOYEE SURVEY**

Housing that is affordable for the people who work within the International Drive CRA is essential in this area so that people can live closer to their jobs and spend less time commuting to work.





Programs that can assist residents in becoming homeowners are needed to help strengthen and preserve neighborhoods like Tangelo Park and future residential developments in the CRA.







There is a benefit to investing in employment training programs and reemployment training programs that support job opportunities within this area.





Affordable, safe and acceptable housing is the key to help families thrive.


A recently added traffic light has made a tremendous difference in the safety of pedestrians and drivers.
