DISCUSSION:

Seven bids were received in response to this Invitation for Bids and evaluated for responsiveness, responsibility, and price reasonableness. The bids received by A.L.G. Landscaping and ProScape, Inc. were deemed non-responsive for failing to submit a complete bid response.

Staff performed a technical evaluation of the bids and determined that each low bid was reasonable based on performance and experience. References provided by both bidders are satisfactory and also have a satisfactory record of performance. Based on previous contracts and research of similar contracts these rates are within industry standards.

The low, responsive, and responsible bidders have the ability and resources to perform in a satisfactory manner.

The **one** Orange County Certified Minority Business Enterprise firm **was not within** of the low bid for bid awards greater than \$2,000,000.01 to \$5,000,000. Hence, the bid preference program in accordance with the County's M/WBE Ordinance, Section 17-324 cannot be applied.
