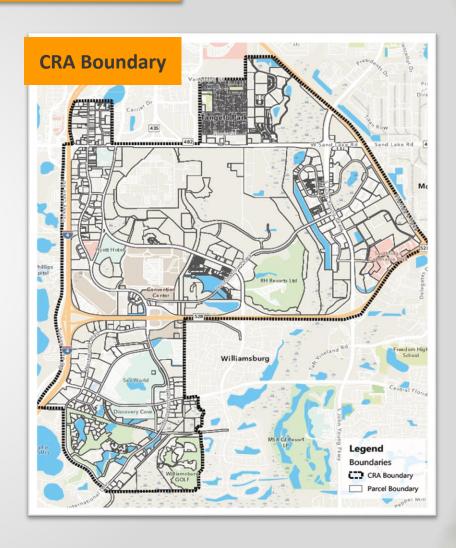


BACKGROUND

INTERNATIONAL DRIVE CRA

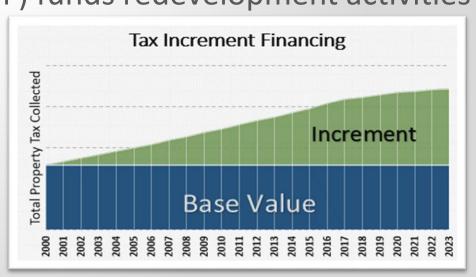
- 7,315 acres
- Created in 1998 (sunsets in 2028)
- Focused on Transportation-related Blight
- Redevelopment Plan Adopted in 1998
- Amended in 2006, 2009, and 2019
- Includes proposed redevelopment activities



BACKGROUND

FUNDING

- Tax Increment Financing (TIF)
- Based on taxable value of properties within CRA
- Capture growth of ad valorem tax revenues within CRA
 - Base Year (1998) taxes continue to support General Fund
 - Growth of taxes in subsequent years (TIF) funds redevelopment activities
- Dedicate those funds to specific improvements within CRA
- Does not impact ad valorem taxes supporting schools
- FY 20 Tax Increment \$22M



MAYOR/BCC DIRECTION

- Update Redevelopment Plan with current data/analysis
- Consider expanded uses of CRA resources to address housing needs and others as may be determined
- Re-evaluate Sunset Date
- Engage with I-Drive Area Employees (November 2020)

REDEVELOPMENT PLAN UPDATE (DRAFT)

- Expanded use of CRA Revenues to Five (5) Key Investment Areas:
 - Transportation
 - Housing
 - Economic Development
 - Community, Cultural and Institutional Programs
 - Beautification and Aesthetics
- Extension of CRA Sunset Date from 2028 to 2040
- Cap on CRA Revenues (return of projected \$81M to General Fund)

KEY DECISION POINTS

- Whether or not to expand use of CRA Revenues
 - Transportation
 - Five Key Investment Areas
- Whether or not to extend CRA Sunset Date
 - 2028
 - -2040
 - Other
- Whether or not to cap CRA Revenues (allows rebate to General Fund)
 - No cap
 - \$22M cap (75%/25% General Funds/CRA)
 - Other

AFFORDABLE AND ATTAINABLE HOUSING

- Housing for All Affordable Housing Solutions for Tangelo Park
 - Housing Repair minor and major homeowner repair program
 - "Missing Middle" Strategies Accessory Dwelling Units Program
- Housing Infill Opportunities
 - Mixed-Income Residential land uses
 - Financial Assistance consistent with criteria adopted for Housing Trust Fund
 - Impact Fee waivers/subsidies available for projects that meet criteria adopted for Housing Trust Fund



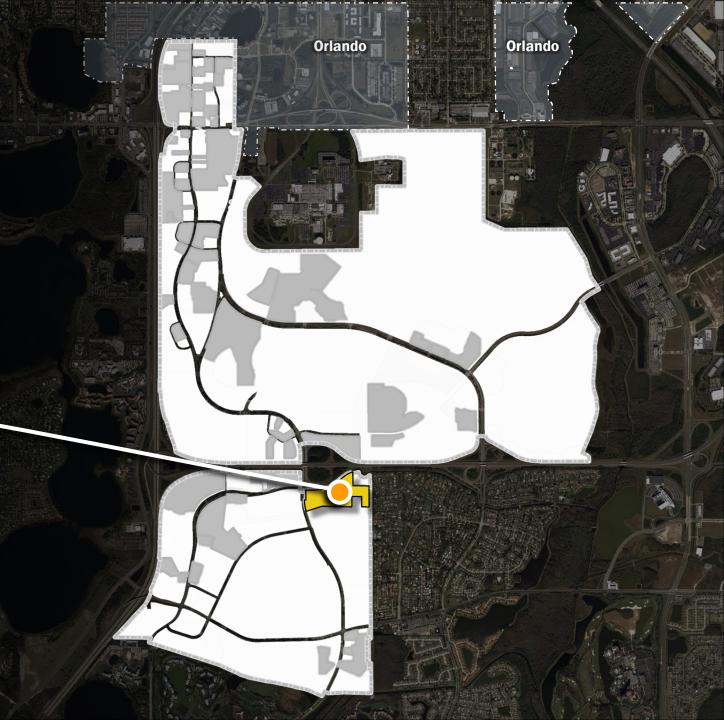
AFFORDABLE AND ATTAINABLE HOUSING

- Catalytic Sites
 - RFP for redevelopment of the two identified catalytic sites for Mixed-Use and Mixed-Income residential land uses
 - Potential combined total of 2,250 units on both sites with density of 65 du/acre

TOTAL = 1,670 Units





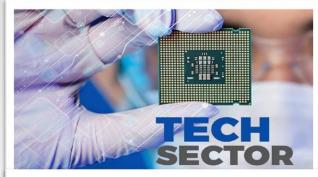






ECONOMIC DEVELOPMENT

- Tourism/Hospitality employee training for upward mobility within the industry

2028 vs 2040 REVENUE PROJECTION

2028 Revenue = \$175.8M (with rebate) \$183.4M (without rebate)

2040 Revenue = \$464.4M (with rebate) \$545.8M (without rebate)

Difference = \$288.6M (with rebate) \$362.4M (without rebate)

I-DRIVE CRA ADVISORY COMMITTEE

- March 29, 2021 Action:
 - Recommend expanded use of CRA Revenues in the five key investment areas with priority established for Tangelo Park community needs in those areas
 - Recommend extension of CRA Sunset Date to 2040

I-DRIVE CRA GOVERNANCE

- Board of County Commissioners is the Governing Board CRA
- Specific projects approved through County's annual budget process
- Past projects implemented through Public Works CIP
- Standard County contracts/procurement process

DECISION OPTIONS FOR BOARD

- No specific deadline/time required for decision
- Option 1: Full Decision Now (Expanded Use; Sunset Date; Cap)
- Option 2: Incremental Decision
 - Expanded Uses to include Housing, Tangelo Park Community Center,
 Economic Development/Jobs Training
 - Continue implementing current transportation program
 - Postpone decision on CRA extension and cap until better understanding of pace of economic recovery
- Option 3: Postpone Any Decision/Status Quo
 - Continue CRA as currently authorized

NEXT STEPS

- Modify Draft Redevelopment Plan Update to reflect any direction received from BCC today
- Schedule Public Hearing (action) May/June
