**SUBJECT:** Ratification of Purchase Order M104177, Change Order No. 1, Turnkey COVID-19  
Testing and Vaccination Services at Barnett Park

**ACTION REQUESTED:**

Ratification of Purchase Order M104177, Change Order No. 1, Turnkey COVID-19 Testing and Vaccination Services at Barnett Park, with CDR Maguire, Inc. dba CDR Health Care, Inc. in the amount of \$3,332,500 for a revised not-to-exceed amount of \$5,492,500.

**PROCUREMENT:**

Change Order No. 1 provides funding for turnkey COVID-19 site infrastructure and management, testing, and vaccination services for first and second doses at Barnett Park for the period of June 1, 2021 through June 30, 2021. The Change Order also included a \$500,000 decrease for May vaccination services, to account for a reduction from 750 to 330 daily doses.

**FUNDING:**

Funding is available in the account number 0001-060-2493-3197.

**APPROVALS:**

The Health Services Department concurs with this recommendation.

**REMARKS:**

The Procurement Division approved emergency services to provide traffic control, registration, testers, vaccinators, medical oversight, and patient vaccination waiting area personnel at Barnett Park under this purchase order. CDR Maguire, Inc. dba CDR Health Care, Inc. will provide all supplies needed to operate the site including personnel, protective equipment, medical supplies, chairs, tables, biohazard waste receptacles, and industry appropriate waste pickup.

Ratification of Purchase Order M104177, Change Order No. 1, Turnkey COVID-19 Testing and Vaccination Services at Barnett Park

CDR Maguire, Inc. dba CDR Health Care, Inc. is currently conducting BinaxNOW rapid antigen testing, Polymerase Chain Reaction (PCR) testing, and data management at Barnett Park for Orange County residents. In an effort to increase the number of people vaccinated in the community, CDR Maguire also started offering vaccinations at Barnett Park. The ability to rapidly identify COVID-19 positive patients and vaccinated residents is necessary to minimizing the spread of COVID-19 in the community. A delay in running this site would reduce the ability of County residents to obtain timely testing results and limit the number of residents able to obtain the vaccine.

After negotiations with CDR Maguire, Inc. dba CDR Health Care, Inc., they reduced the prices per test effective February 1, 2021. This negotiation includes a reduced price per PCR test from \$85 to \$75, reduced site personnel fee per test from \$35 to \$25, and reduced the site infrastructure and management fee per test from \$27.50 to \$10. Further reduction in the price per PCR test has resulted in an additional reduction from \$75 to \$70 which has been applied to this change order.
