### **RECOMMENDATION:**

Selection of Hellmuth, Obata, Kassabaum, Inc. to provide Design and Construction Administration Services for Corrections Horizon Dormitory Improvements, Request for Proposals Y21-808-JS. Further request the Board authorize the negotiation and execution of a contract by the Procurement Division provided that it does not exceed the budget of \$2,000,000.

This item was evaluated by the Procurement Committee on May 20, 2021. Commissioner Maribel Gomez Cordero was assigned to the Procurement Committee.

## **PURPOSE:**

The Consultant shall provide services that includes a schematic design, design development, construction documents, permitting, bidding, and construction administration. This project is located in District 6.

## DISCUSSION:

The focus of this project is to increase security level of cell units through demolition of deteriorated metal cell unit fronts, along with the corresponding HVAC chase in each unit and reconstructing with more conventional construction materials, address the non-compliant cell windows at each unit. The project includes LED lighting that will meet or exceed existing lighting energy efficiency and sustainable lighting system. One common area shower stall per level shall be converted into a high-security shower stall.

As part of the County's commitment to sustainability and high performing buildings, the Consultant shall identify opportunities for integrated design and construction with respect to best energy and environmental practices within the scope of work and include them into the project. Such as, LED lighting, occupancy sensors, energy efficiency, durability, and reliability.

The Consultant will perform the following tasks:

- 1. Design Phase Services
- 2. Permit Phase Services
- 3. Bidding Phase Services
- 4. Construction Contract Administration Phase Services
- 5. Post Construction Services

Two proposals were received in response to the Request for Proposals (RFP). The Procurement Committee evaluated the proposals in accordance with the criteria set forth in this RFP. The proposal submitted by Strollo Architects, Inc. scored too low for Board consideration.

The consensus scores of the Procurement Committee are attached.
