REMARKS:

The County has an interest in a portion of the Frontage Road, pursuant to that certain Quit Claim Deed between Florida Department of Transportation and County recorded on January 9, 2007 in Book 09056, Page 1496, of the Public Records of Orange County, Florida (Parcel). The School Board of Orange County (OCPS) has requested that the County transfer the County's interest in the Parcel to OCPS. Public Works Engineering Division has reviewed and agreed to OCPS's request.

This County Deed will convey County's interests in the Parcel to OCPS. As a condition precedent to this conveyance Section 125.38, Florida Statutes, requires this Resolution.

COUNTY DEED

THIS DEED, made as of the date signed below, by Orange County, a charter county and political subdivision of the state of Florida, whose address is P. O. Box 1393, Orlando, Florida 32802-1393, GRANTOR, and The School Board of Orange County, Florida, a public corporate body organized and existing under the Constitution and the laws of the State of Florida, whose address is 445 West Amelia Street, Orlando Florida 32801, GRANTEE.

WITNESSETH: That the GRANTOR, for and in consideration of the sum of \$1.00 and other valuable considerations, in hand paid by the GRANTEE, the receipt whereof is hereby acknowledged, does hereby remise, release, and quit-claim unto the said GRANTEE forever, all the right, title, interest, claim, and demand which the GRANTOR has in and to the lot, piece, or parcel of land, situate, lying and being in the county of Orange, State of Florida, described below and on the attached Exhibit "A" (the "Property"), subject to the following terms, conditions, and reservations:

- 1. No commercial transmission or receiving devices which carry signals that could cause interference with the operations of the Florida Department of Transportation, Turnpike Enterprise, an agency of the State of Florida, may be placed or constructed on the Property: this restriction shall run with the land in perpetuity and be binding on all successors in title.
- 2. To the extent the Property remains a roadway, the Grantee accepts all responsibility for operation and maintenance of the roadway, including all curbs, culverts, and drainage structures within the right-of-way at the time of transfer.
- 3. All obligations of the Grantor under any maintenance or utility agreements or other such agreements existing at the time of this conveyance shall become the responsibility of the Grantee.
- 4. The Property shall be used by the Grantee for a public purpose.


