Consideration: AN ORDINANCE AMENDING THE ORANGE COUNTY CODE OF ORDINANCES RELATING TO FLOODPLAIN MANAGEMENT; AMENDING CHAPTER 19 ("FLOODPLAIN MANAGEMENT") TO ADOPT FLOOD HAZARD MAPS, TO DESIGNATE A FLOODPLAIN ADMINISTRATOR, TO ADOPT PROCEDURES AND CRITERIA FOR DEVELOPMENT IN FLOOD HAZARD AREAS, AND FOR OTHER PURPOSES; AND AMENDING CHAPTER 34 ("SUBDIVISION REGULATIONS") TO GOVERN DEVELOPMENT WITHIN SPECIAL FLOOD HAZARD AREAS; AND PROVIDING FOR AN EFFECTIVE DATE.
