Subject: Award of Invitation for Bids Y21-772-R2, Dr. Phillips Park Playground Improvements

ACTION REQUESTED:

Approval to award Invitation for Bids Y21-772-R2, Dr. Phillips Park Playground Improvements, to the low responsive and responsible bidder, Sloan Builders, Inc. in the total contract award amount of \$589,612.

PROCUREMENT:

Work under this contract consists of removal of existing playground and related site improvements and construction of new playground equipment, resilient surfacing and associated fencing, furniture, and hardscape. The project is located in District 6.

FUNDING:

Funding is available in account number 1050-062-2160-6310.

APPROVALS:

The Capital Projects and Business Development Divisions concur with this recommendation.

REMARKS:

Five bids were received in response to this Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. The bids from Mulligan Constructors, Inc., SkyBuilders USA, LLC, and CORE Engineering & Construction, Inc. were deemed non-responsive for failure to achieve the M/WBE participation goal or provide sufficient good faith effort documentation. The bid submitted by Summit Design Build was deemed non-responsive as their electronic bid package was corrupted and could not be verified. References provided were satisfactory for this type of work and Sloan Builders, Inc., has been determined to be responsible. Therefore, award is recommended to Sloan Builders, Inc.

The Business Development Division evaluated all four bids submitted for this project. The Business Development Division completed an M/WBE Availability Analysis. The scope of services for this project had Minority/Women Business Enterprise availability. As a result, the M/WBE goal is reduced to 3%. At the time of bid opening, at least 37 M/WBE firms were certified to provide the scope of services at the subcontract level.

The apparent low bidder, submitted by Mulligan Constructors, Inc., reported 0.00% in M/WBE participation and did not achieve the M/WBE participation goal. They did not submit good faith effort documentation, specify their in-house scope of services and the scope of services for the subcontractors on attachment C-2. Please note the following certified M/WBE participation:

The apparent third low bidder, submitted by Orange County MBE firm SkyBuilders USA, LLC, is bidding as a Prime contractor. Therefore, SkyBuilders USA, LLC., is required to self-perform no less than 51% of the contract per Sec. 17-321 per the M/WBE Ordinance. In the event this requirement is not achieved, other M/WBE's will have to be included to achieve the 25% M/WBE goal. Sky Builders USA, LLC reported self-performing 0.00% with 0.00% subcontractor's participation listed on attachment C-2. They did not submit good faith effort documentation, specify their in-house scope of services and the scope of services for the subcontractors on attachment C-2. The M/WBE participation goal was not met. Please note the following certified M/WBE participation:
