# **RECOMMENDATION:**

Selection of one firm and an alternate to provide Audio Visual Equipment and Show Technology Services for the Orange County Convention Center, Request for Proposals Y21-1006-RM, from the following firms listed alphabetically:

CCR Solutions, Inc.

LMG, LLC

Request authorization for the Procurement Division to negotiate and execute a contract with a total estimated revenue of \$4,750,000 for a five-year term. Further request authorization for the Procurement Division to renew the contract for two additional one-year terms.

Proposals were evaluated by the Procurement Committee on August 4, 2021. Commissioner Nicole Wilson was assigned to the Procurement Committee.

#### PROCUREMENT:

This revenue-sharing contract provides audio-visual equipment, supplies, and technology services under a concession contract for the clients of the Orange County Convention Center (OCCC). The Contractor shall be the preferred, non-exclusive service partner to provide audio visual equipment and show technology services at the OCCC. The Contractor shall furnish all requested quantities of new or like new state-of-the-art audio/visual and high end specialty equipment and related show technology services to clients of the OCCC. Equipment to be furnished shall include, but not be limited to, projectors and screens, LCD/LED monitors, high definition audio visual equipment, camera and optics systems, streaming and recording systems (onsite and offsite), digital audio console systems, wired/wireless microphones and related equipment, LED lights and displays, moving and stationary lighting, truss and motor systems, and other audio visual and lighting equipment and show technology components.

The Contractor also provides qualified employees to setup, troubleshoot, and operate equipment if required by the client or the OCCC.

### **FUNDING:**

Not applicable. This is a revenue contract.

## APPROVALS:

The OCCC Event Management Division and Sales Division concur with this recommendation.

### **REMARKS:**

Two proposals were received in response to RFP Y21-1006-RM. The contract will provide revenue to the Convention Center based on a percentage of the Contractor's gross sales received from the rental of equipment and related services to the OCCC clients.
