The list of properties selected to apply for tax deed consists of <u>Fourteen (14)</u> item(s). These items will require a Title Search Fee of \$150.00, a Tax Collector Fee of \$75.00 and a Online TDA Fee of \$75.00 for a total due of \$4,200.00. Additionally, a *Notice to Tax Collector of Application for Tax Deed* (form DR-512) must be submitted with the remitted funds for each application.
