ACTION REQUESTED:

Approval of Amendment No. 6, Contract Y4-810, Professional Engineering Design Services for All-American Boulevard (from Clarcona – Ocoee Road to Forest City Road), with HDR Engineering, Inc., in the amount of \$181,153.57, for a revised total contract amount of \$1,290,734.44.

PROCUREMENT:

This amendment is needed to provide updates to the final engineering plans prepared in April 2020 to meet the current design standards, add public involvement coordination as requested by the Florida Department of Transportation due to the railroad crossing, add subsurface utilities verification due to potential new conflicts, railroad coordination with all entities due to new requirements and add improvements as needed for the "Goes-with" Kennedy Boulevard project, and modify plans as needed due to right-of- way issues. The original contract fee structure and rates apply to this amendment.

Approval of Amendment No.6, Contract Y4-810, Professional Engineering Design Services for All-American Boulevard (from Clarcona-Ocoee to Forest City Road)

DISCUSSION:

The Board approved the selection of HDR Engineering, Inc. on August 3, 2004, and authorized negotiation and execution of a contract by the Procurement Division provided the contract does not exceed the budget amount of \$930,000. The contract was executed on May 27, 2005, for a total contract amount of \$890,603.37.

Deleted Pay Item 5F (Minimization of Compensable Impacts Report), and added funds from 5F to Pay Item 5A (Right-of-Way Maps 30%, 60%, 90%, 100%, and Final).

Designed the improvements to Edgewater Drive from Clarcona-Ocoee Road to Magnolia Homes Road.

Increased the scope and fees for the addition of a pond between existing All American Boulevard and the Little Wekiva River to accommodate stormwater treatment for the proposed improvements east of the Little Wekiva River.
