ACTION REQUESTED:

Approval to award Invitation for Bids Y21-7028-FH, Capehart Park Roof Replacement to the low responsive and responsible bidder, Alpha Roofing and Sheet Metal, LLC in the total contract award amount of \$190,000.

PROCUREMENT:

Work under this contract consists of the replacement of the assembly with new metal roof assembly, removal of the assembly, and installation of new steel framing, metal deck, and metal roof assembly. The project is located in District 3.

FUNDING:

Funding is available in account number 1023-043-0252-3810.

APPROVALS:

The Capital Projects and Business Development Divisions concur with this recommendation.

REMARKS:

Two bids were received in response to this Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. The bid submitted by Dorothy Builds, LLC was deemed non-responsive as it did not include copy of the Official Bid Form, Project Expenditure Report Form, Relationship Disclosure Form, and Verification of Employment Form. The bid submitted by Alpha Roofing and Sheet Metal, LLC is considered reasonable based on the engineer's estimate. References provided were satisfactory for this type of work and Alpha Roofing and Sheet Metal, LLC has been determined to be responsible. Therefore, award is recommended to Alpha Roofing and Sheet Metal, LLC.

The Business Development Division evaluated one bid submitted for this project. The Business Development Division completed an M/WBE Availability Analysis. The scope of services for this project had Minority/Women Business Enterprise availability. As a result, the M/WBE goal is 25%. At the time of bid opening, at least 51 M/WBE firms were certified to provide the scope of services at the subcontract level.

The apparent low bidder, submitted by Alpha Roofing and Sheet Metal, LLC, reported 31.58% in M/WBE participation. They met the 25% M/WBE subcontractor goal. Please note the following certified M/WBE participation:
