RECOMMENDATION:

Selection of one firm and two ranked alternates to provide Statement Printing and Mailing Services-Orange County Utilities Department, Request for Proposals, Y21-1023-TJ, from the following firms listed alphabetically:

Cathedral Corporation Envelopes and Forms, Inc. dba SureBill Infosend, Inc.

Request authority for the Procurement Division to negotiate and execute a one-year contract within a budget of \$807,620. Further request authorization to renew the contract for four additional one-year terms.

Proposals were evaluated by the Procurement Committee on September 22, 2021. Commissioner Christine Moore was assigned to the Procurement Committee.

PURPOSE:

Services will be provided for utility statement and notification letter printing, folding, inserting, metering, and mailing for the Utilities Department.

APPROVALS:

The Utilities Department and Business Development Division concur with this recommendation.

REMARKS:

Eight proposals were received in response to this Request for Proposals (RFP).

The Procurement Committee evaluated the proposals in accordance with the criteria set forth in this RFP.

Datamax Corporation was deemed non-responsive for modifying the Fee Schedule form. Doxim (Pinnacle Data Systems) was deemed non-responsive for failing to complete all lines on the Fee Schedule form and added terms that conflict with the RFP. Form Maker Software, Inc. dba Kubra was deemed non-responsive for failing to comply with the confirmation statement in TAB 1 Pre-requisite Requirement. The proposals for Northeast II, Inc. dba TC Delivers, and Sebis Direct, Inc. scored too low for Board consideration.

The Procurement Committee's consensus scores are attached.
