Consideration: Request for Variances in the R-2 zoning district as follows: 1) To allow a 1,088 sq. ft. detached Accessory Dwelling Unit (ADU) in lieu of a maximum of 626 sq. ft.; 2) To allow an ADU with 3 bedrooms in lieu of a maximum of 2; and 3) To allow an ADU that is not designed to be similar and compatible with the primary dwelling unit, with the same exterior finish material and similar architectural details.
