**Call to Order**

The meeting was called to order at 6:05 p.m.

**Pledge of Allegiance****I. Chair / Vice Chair Comments**

Chair Hartage provided brief comments to the CRC. Chair Hartage introduced Erica Jackson, the newest member to the CRC. Member Jackson is an appointee of District 1. She provided a brief history of her background and varied experience. Chair Hartage announced that the Procurement Committee meeting to select the CRC General Counsel will be held on March 29, 2023, at 3:00 p.m., in the Facilities Management Building located at 2010 E. Michigan Street. It is a public meeting and CRC members are invited to attend. The committee will make a selection and bring forth that selection to the CRC for approval at the next CRC meeting.

Chair Hartage will bring forth draft Bylaws to the CRC, which will provide rules on how to set up committees and CRC business moving forward. He will seek member input at the next CRC meeting and the final Bylaws will be voted and approved by the full CRC.

**II. Invited Guest Speaker Orange County Mayor Jerry L. Demings**

County Mayor Demings welcomed members of the 2023-2024 Charter Review Commission and thanked them for their willingness to serve on the CRC on behalf of the citizens of Orange County. The Mayor expressed the goal of the CRC is to review the County Charter, all phases of County government and decide whether proposed revisions and/or amendments to the County Charter are necessary. County Mayor Demings shared that the preservation of home rule, term limits, non-partisan elections and having one authoritative figure for the executive and legislative branch is extremely important to the longevity of Orange County. CRC members asked questions to County Mayor Demings relating to:

- Structure of the offices within the Mayor and County Commissioners along with their roles and responsibilities
- Mayor's legislative and executive roles and how it affects County Commissioners ability to work with members of County Staff that report to the Mayor about issues or projects taking place in a particular district
- Single member districts
- Separation of power between executive and legislative branches
- Lengthening term limits
- Transformational change regarding housing, transportation, and environment issues as it relates to the length of term limits
- Creation of a Citizen Review Board to review citizen complaints against the Orange County Sheriff's Office
- Board of County Commissioners (BCC) approval process of the Orange County Sheriff's Office budget
- Determining a defense of future Charter amendments in potential litigation
- Creation of a Citizens Advisory Committee regarding the Corrections Department
- Public Initiatives and Referendums within the Charter
- Casinos
- Sections of the Charter that can be strengthened to protect home rule

Member Batchelor requested the County Attorney's Office provide an update on the latitude of the Charter process along with the County's Legislative Government Affairs Office providing an update on pending items in the Florida Legislature that may preempt their proposed Charter amendments. Discussion ensued.

### **IV. Member Comments**

CRC members commented on the following issues: term limits, lack of funding for transportation, review of current operational structure of county departments and the ability of staff to assist in both the interests of the Mayor and County Commissioners, affordable housing crisis, County Attorney not referenced in the Charter, Community Advisory Board for Transportation, authority of County to impose rules on municipalities, review of the executive and legislative branch, expansion of County Commission districts, creation of a Correctional Citizens Advisory Committee, formation of standing committees and appointments of CRC members to those committees, petition initiative referendum process, and scheduling Sunshine Meetings between CRC members. Discussion ensued.

A motion was by Member Callan, seconded by Member Wynn, to limit each CRC member to one round of comments not to exceed two (2) minutes during the open discussion of member comments, except for follow up questions. The motion carried by the following vote:
