Call to Order

County Mayor Jacobs called the meeting to order at 5:01 p.m.

Opening Remarks

County Mayor Jacobs welcomed the attendees and reviewed the order of the public hearings.

County Administrator Lalchandani announced that the purpose of the public hearing is to consider and adopt tentative millages and budgets for the fiscal year beginning October 1, 2018, and ending September 30, 2019. Further, he announced that all adjustments to the originally approved budget made at the budget worksessions are incorporated into this budget.

I. BUDGET PUBLIC HEARINGS

1. <u>18-1023</u> Mandatory Refuse Rate Resolution

Mandatory Refuse Rate Resolution and exemptions from full solid waste collection service

Consideration: RESOLUTION OF THE ORANGE COUNTY BOARD OF COUNTY COMMISSIONERS ESTABLISHING THE CALENDAR YEAR 2019 SPECIAL ASSESSMENT AT \$230.00 FOR RESIDENTIAL FULL SOLID WASTE AND RECYCLING COLLECTION, WITHIN UNINCORPORATED ORANGE COUNTY, PURSUANT TO CHAPTER 32 OF THE ORANGE COUNTY CODE. THE SPECIAL ASSESSMENT SHALL APPEAR ON THE PROPERTY TAX BILL AND SHALL BE COLLECTED IN THE SAME MANNER AS AD VALOREM TAXES, AS AUTHORIZED BY STATE LAW.

David Gregory, Manager, Solid Waste Division, presented remarks regarding mandatory garbage and recycling rate collection service for 2019.

A motion was made by Commissioner Siplin, seconded by Commissioner Thompson, to adopt Resolution 2018-M-27, setting the mandatory residential full solid waste and recycling collection special assessment rate at \$230.00 per household for Calendar Year 2019; and further, the hauler reimbursement rates for Calendar Year 2019 as follows:

Zone 1: \$141.20 per residential unit;

Zone 2: \$174.66 per residential unit; Zone 3: \$152.07 per residential unit; Zone 4: \$123.34 per residential unit; Zone 5: \$125.52 per residential unit.

A motion was made by Commissioner VanderLey, seconded by Commissioner Thompson, to accept and adopt the Non-Ad Valorem Assessment Roll as presented, in the unit of measurement and the respective amounts by subdivision and/or parcel identification number as stated in the assessment roll. Consideration: A RESOLUTION ADOPTING A TENTATIVE MILLAGE RATE FOR ORANGE FOR ALL OTHER PURPOSES COUNTY AND OR **ENTITIES IDENTIFIED** IN THIS RESOLUTION: STATING THE PERCENTAGE BY WHICH THE TENTATIVE MILLAGE RATE AS ADOPTED HEREIN IS MORE THAN OR LESS THAN THE INDIVIDUAL ROLLED BACK IDENTIFIED: MILLAGE RATE FOR EACH PURPOSE OR ENTITY STATING THE PERCENTAGE INCREASE OR DECREASE OF PROPERTY TAXES FOR ORANGE COUNTY PURPOSES AND ENTITIES IDENTIFIED HEREIN; PROVIDING AN FOR THE EFFECTIVE DATE.

County Administrator Lalchandani announced that all adjustments to the originally approved budget are incorporated into the budget.

Kurt Petersen, Manager, Office of Management and Budget, announced the tentative countywide millage rate and outlined the countywide tax millage information for all taxing units under the Board of County Commissioners and the aggregate millage rate.

A motion was made by Commissioner Thompson, seconded by Commissioner Clarke, to adopt Resolution 2018-M-28, setting the tentative countywide millage rate. The motion carried by the following vote:

Kurt Petersen, Manager, Office of Management and Budget, presented the proposed budget amount for fiscal year 2018/2019.

A motion was made by Commissioner Clarke, seconded by Commissioner Love, to adopt Resolution 2018-M-29, adopting the County budget. The motion carried by the following vote:


