Opening Remarks

County Mayor Demings welcomed the attendees and reviewed the order of the public hearings.

County Administrator Brooks announced that the purpose of the public hearing is to consider and adopt tentative millages and budgets for the fiscal year beginning October 1, 2019, and ending September 30, 2020.

I. BUDGET PUBLIC HEARINGS

1. 19-1165 Mandatory Refuse Rate Resolution

Mandatory Refuse Rate Resolution and exemptions from full solid waste collection service

Consideration: RESOLUTION OF THE ORANGE COUNTY **BOARD** OF COUNTY **COMMISSIONERS ESTABLISHING** THE CALENDAR YEAR 2020 SPECIAL ASSESSMENT FULL SOLID WASTE AND RECYCLING AT \$230.00 FOR RESIDENTIAL COLLECTION. WITHIN UNINCORPORATED ORANGE COUNTY, PURSUANT TO CHAPTER 32 OF ORANGE COUNTY CODE. THE SPECIAL ASSESSMENT **SHALL** APPEAR ON THE PROPERTY TAX BILL AND SHALL BE COLLECTED IN THE SAME MANNER AS AD VALOREM TAXES, AS AUTHORIZED BY STATE LAW.

David Gregory, Manager, Solid Waste Division, presented remarks regarding mandatory garbage and recycling rate collection service for fiscal year 2019/2020.

Zone 1: \$142.36 per residential unit; Zone 2: \$176.10 per residential unit; Zone 3: \$153.32 per residential unit; Zone 4: \$124.35 per residential unit;

Zone 5: \$126.55 per residential unit.
