#### Call to Order

County Mayor Demings called the meeting to order at 5:02 p.m.

**Present:** 7 - Mayor Jerry L. Demings, Commissioner Nicole Wilson, Commissioner Christine Moore, Commissioner Mayra Uribe, Commissioner Maribel Gomez Cordero, Commissioner Emily Bonilla, and Commissioner Victoria P. Siplin

#### **Opening Remarks**

County Mayor Demings thanked everyone for joining and reviewed the order of the public hearings.

County Administrator Brooks announced that the purpose of the public hearing is to consider and adopt tentative millages and budgets for the fiscal year beginning October 1, 2022, and ending September 30, 2023.

#### I. BUDGET PUBLIC HEARINGS

## 1. 22-872 Mandatory Refuse Rate Resolution

Mandatory Refuse Rate Resolution and exemptions from full solid waste collection service

Consideration: RESOLUTION OF THE **ORANGE** COUNTY **BOARD** OF COUNTY **COMMISSIONERS** ESTABLISHING THE CALENDAR YEAR 2023 SPECIAL ASSESSMENT \$260.00 FOR RESIDENTIAL FULL SOLID WASTE AND RECYCLING COLLECTION, WITHIN UNINCORPORATED ORANGE COUNTY, PURSUANT TO CHAPTER 32 OF ORANGE COUNTY CODE. THE SPECIAL ASSESSMENT SHALL APPEAR ON THE PROPERTY TAX BILL AND SHALL BE COLLECTED IN THE SAME MANNER AS AD VALOREM TAXES, AS AUTHORIZED BY STATE LAW.

David Gregory, Manager, Solid Waste Division, presented remarks regarding mandatory garbage and recycling rate collection service for fiscal year 2022/2023.

A motion was made by Commissioner Uribe, seconded by Commissioner Gomez Cordero, to adopt Resolution 2022-M-44, setting the mandatory residential full solid waste and recycling collection special assessment rate at \$260 per household for Calendar Year 2023; and further, the hauler reimbursement rates for Calendar Year 2023 as follows:

Zone 1: \$147.73 per Residential Unit Zone 2: \$182.74 per Residential Unit Zone 3: \$159.11 per Residential Unit Zone 4: \$129.04 per Residential Unit Zone 5: \$131.33 per Residential Unit

Consideration: ADOPTION OF THE NON-AD VALOREM ASSESSMENT ROLL AUTHORIZING THE ORANGE COUNTY TAX COLLECTOR TO USE THE UNIFORM METHOD OF COLLECTION OF NON-AD VALOREM ASSESSMENTS LEVIED BY THE ORANGE COUNTY BOARD OF COUNTY COMMISSIONERS AS PROVIDED IN SECTION 197.3632, FLORIDA STATUTES.

A motion was made by Commissioner Gomez Codero, seconded by Commissioner Wilson, to accept and adopt the Non-Ad Valorem Assessment Roll as presented, in the unit of measurement and the respective amounts by subdivision and/or parcel identification number as stated in the assessment roll. ## 3. 22-157 All Other Millages and Funds

Consideration: A RESOLUTION ADOPTING A TENTATIVE MILLAGE RATE FOR ORANGE COUNTY AND FOR ALL OTHER PURPOSES OR **ENTITIES IDENTIFIED THIS** RESOLUTION; STATING THE PERCENTAGE BY WHICH THE TENTATIVE MILLAGE RATE AS ADOPTED HEREIN IS MORE THAN OR LESS THAN THE INDIVIDUAL ROLLED BACK MILLAGE RATE FOR EACH **PURPOSE** OR **ENTITY** IDENTIFIED: STATING THE PERCENTAGE INCREASE OR DECREASE OF PROPERTY TAXES FOR ORANGE COUNTY FOR THE **PURPOSES** AND ENTITIES IDENTIFIED HEREIN; PROVIDING EFFECTIVE DATE.

County Administrator Brooks announced that all adjustments to the originally approved budget are incorporated into the budget.

Kurt Petersen, Director, Office of Management and Budget, announced the tentative countywide millage rate and outlined the countywide tax millage information for all taxing units under the

Board of County Commissioners (BCC) and the aggregate millage rate.

A motion was made by Commissioner Siplin, seconded by Commissioner Gomez Codero, to adopt Resolution 2022-M-45, setting the tentative countywide millage rate. The motion carried by the following vote:

Kurt Petersen, Director, Office of Management and Budget, presented the proposed budget amount for fiscal year 2022/2023.

A motion was made by Commissioner Uribe, seconded by Commissioner Siplin, to adopt Resolution 2022-M-46, adopting the County budget. The motion carried by the following vote:
